

■ 42% offer voluntary insurance


### CURRENT BENEFITS LANDSCAPE

The percentage of companies making changes to their benefits programs


KEY: ■ Changed in 2016 ■ Planned for 2017




Increased employees' copays




Increased employees' share of premium




Reduced the number of major medical/health plan options




Moved to a private exchange

### HAPPINESS



**72%** say improving their benefits package would make them happier employees.

### GROWING IMPORTANCE OF VOLUNTARY INSURANCE

**44%** agree that they regularly underestimate the total cost of an injury or illness, including medical, household and out-of-pocket costs.



**27%** of employees say that if their employer did not provide adequate health insurance coverage,

they would purchase additional, affordable insurance products.

### VALUE OF BENEFITS

**64%** say a benefits package offering is extremely or very important to their job satisfaction, and **55 percent** say it's extremely or very important to their employer loyalty.

**52%** are at least somewhat likely to accept a job with slightly lower pay but better benefits.

**36%** say improving their benefits package is one thing their employer could do to keep them in their jobs.

**17%** have left a job or turned down a job offer due to the benefits offered.

### FINANCIAL WELL-BEING



**61%** of employees would be able to pay less than \$1,000 for out-of-pocket expenses if an unexpected serious illness or accident occurred today.

**11%** of employees say high medical costs have negatively impacted their credit scores.

The 2017 Aflac WorkForces Report is the seventh annual study examining benefits trends and attitudes.
